

#UpgradeMyKIA TERMS & CONDITIONS

1. Terms and conditions applicable to the #UpgradeMyKIA" Competition ("Competition") conducted by KIA Motors South Africa (Pty) Ltd ("Promoter").
2. The Competition will run from Friday 5th October to Friday 31st May 2019. Entries received after the closing date will not be considered.

WHO CAN ENTER

1. Participants must be 18 years or older, be the registered owner of a KIA vehicle, have a valid driver's license, have a valid identity document, be a South African citizen or a permanent resident of the Republic of South Africa and reside in the Republic of South Africa during the period of the Competition up until the redemption of the prize ("Participants"/"you"/"your").
2. Participants wishing to enter and eligible for a prize must register on www.upgrademykia.co.za. To be eligible for an upgrade participants must be owners of the KIA vehicle indicated in their competition submission. Additionally, the KIA vehicle indicated in the participants entry must be fully paid up/settled with their financing bank and be three years or older.
3. Only 1 (one) entry per person will be considered by the judges, winners will be determined according to the judges discretion.
4. Entries must be entered by the participant and not by a third party doing so on the participant's behalf.

HOW TO ENTER

1. Participants are to register their details and motivate why they deserve a KIA upgrade from 5th October 2018 to 31st May 2019, on www.upgrademykia.co.za.
2. The winners will be determined during and after the registration period and will be selected by a panel of judges.
3. The winners will be announced as and when selected from November 2018 to June 30th 2019. The winner will be contacted via telephone or e-mail on the phone number and/or e-mail address registered on www.upgrademykia.co.za
4. KIA Motors South Africa will make 3 (three) attempts to contact and notify the selected winner. If the selected winner cannot be contacted personally after 3 (three) attempts, or if after first being contacted by the Promoter, is not reachable, or the winner fails to provide the Promoter with the required information to hand over the prize, the winner will forfeit the prize and a replacement winner will be selected from the names drawn from remaining qualifying participants. This process shall continue until the winner has been contacted and the prize has been awarded in terms of the Competition rules.

5. KIA Motors South Africa (Pty) Ltd will facilitate all vehicle distribution arrangements.

PRIZE

1. Participants can enter and stand a chance to win 1 (one) of 3 (three) vehicle upgrades. An upgrade is the latest model year of the KIA vehicle the participant owns. Winners will be required to cede their existing vehicle to KIA in exchange for the newer vehicle of similar or equivalent specification.

The prize does not cover any other cost of the winner whatsoever, specifically any value added services, maintenance plans, fuel, or insurance costs.

2. The prize is only valid for an upgrade of the owners current vehicle and does not extend to any deal top ups or cash equivalent prizes.

CONSUMER PROTECTION AND DATA PRIVACY

1. Nothing in these terms and conditions is intended to, or must be understood to, unlawfully restrict, limit or avoid any rights or obligations, as the case may be, created for either the Participant or the Promoter in terms of the Consumer Protection Act.
2. By entering, a Participant acknowledges that personal information about the Participant will be shared with the Promoter and KIA Dealerships to the extent necessary to conduct the Competition and for the prize to be delivered to prize winner.
3. All personal information relating to the Participants will be used solely in accordance with South African consumer and data protection legislation.
4. By entering this competition and winning, the winner (and to whom they give the second ticket too) may be required to participate in marketing or promotional activities that include social media postings.

GENERAL

1. The Promoter of this competition is KIA Motors South Africa (Pty) Ltd, registration number 1968/003273/07.
2. Participants may not enter or receive a prize if they are directors, members, partners, employees, agents of or consultants of the Promoter and their subsidiaries, holding companies, divisions and/or associated companies or of the advertising or promotion agencies or any other person who directly or indirectly controls or is controlled by KIA Motors South Africa, or their spouses, life partners, immediate family members or business partners.
3. By entering this Competition, all Participants agree to be bound by these terms and conditions, and the Promoters decision regarding any issue with the Competition will be final and binding and no correspondence will be entered into.
4. Incomplete or incorrect entries will not be eligible to be entered into the draw. The Promoter and KIA Dealerships within their sole discretion will determine whether the Participant did a test drive or not based on the pre-announced entry mechanics, as promoted online and in all KIA Dealerships.
5. The prize is not transferable or negotiable and may not be exchanged for cash. The Promoter reserves the right to substitute the prize for an alternative prize of equal or greater value should the prize promoted not be available due to unforeseen circumstances.
6. The Promoter and KIA Dealerships will not be liable for any loss suffered as a result of incomplete or incorrect information provided.

regards to the Competition, if it would be unlawful to award the prize or if the winner fails to accept the prize after 3 (three) attempts for any reason whatsoever, if after first being contacted by the Promoter, is not reachable, or the winner fails to provide the Promoter with the required information to hand over the prize. In this instance the winner will be disqualified and forfeit the prize. The Promoters decision shall be final and no correspondence will be entered into.

When claiming the prize, the Promoter reserves the right to request the winner to provide to the Promoter with positive identification, proof of ownership (including a valid identity document) and proof of driver's license valid during the period of the Competition, failing which they may be disqualified and forfeit the prize.

12. To the extent permitted by law, the Promoter will not be liable for any defects in the prize or any losses caused by such defects or losses arising from incorrect or inaccurate information supplied by Participants.
13. The laws of the Republic of South Africa shall govern these competition terms and conditions and the courts of South Africa shall have exclusive jurisdiction.
